# Youth Retreat PARTICIPANTS CONDUCT CODE:

- 1. All cars will be parked at all times. Keys must be turned in at check-in.
- 2. No one is to leave the Youth Retreat without permission.
- 3. Possession of tobacco products/illegal drugs will result in immediate dismissal. No alcoholic beverages, fireworks, pornographic materials, weapons (knives, scissors, sharp objects.) Possession will result in dismissal.
- 4. Cell Phone Policy: We will not be allowing phones during service and meeting times during Youth Retreat. It cuts out distractions, and helps you focus on building new friendships in the down time.
- 5. Everyone must observe christian conduct, respect for authority and fellow participants. Lack of cooperation, unnecessary roughness, unwholesome attitudes, and violations of participants conduct code will result in dismissal from Youth Retreat. No refunds given!
- 6. No one is allowed in off limits areas.
- 7. The entire daily schedule must be observed by everyone. Each student will perform duties as part of the privilege of being here.
- 8. The dress code, as stated below, will be enforced at all times.

# **Dress Code:**

Because our event serves students from many different backgrounds & value systems, we've adopted a strict dress code for all students and staff.

- 1. Modest shirts, shorts, and pants may be worn.
- 2. Shoes must be worn at all times.
- 3. Wear clothes that you can wear to both service time and group games.

### UNACCEPTABLE ATTIRE THAT CANNOT BE WORN:

- 1. No shirts cut to low in chest area. Guys must wear shirts at all times in public areas. No crop tops due to actives and worship during service time.
- 2. No short shorts. They do not have to be finger tip length, but appropriate length that nothing is too tight or too short.
- 3. Immodest clothing or garments that are too short, too low cut, or too tight.
- 4. Any clothing or garments that supports alcohol, drugs, rock groups, occult, sex, tobacco, violence or questionable designs. If any doubt do not wear it.

# YOUTH RETREAT PARENTAL CONSENT FORM

#### TO WHOM IT MAY CONCERN:

The undersigned do hereby give permission for our (my) child to attend and participate in Youth Retreat. We (I) authorize an adult, in whose care the minor has been entrusted, to consent to any X-ray examination, anesthetic, medical, surgical, or dental diagnosis or treatment, and hospital care, to be rendered to the minor under the general or special supervision and on the advice of any physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or said hospital.

The undersigned shall be liable and agree(s) to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child pursuant to authorization.

Should it be necessary for our (my) child to return home due to medical reasons or otherwise, the undersigned shall assume all transportation costs.

The undersigned does also hereby give permission for our (my) child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in Youth Retreat.

In consideration of my use of the Trinity Assembly of God (hereinafter TAG) facilities located at 70 Maranatha Drive, White Hall, WV 26554, as set forth in the completed Facility Use Agreement, I/we, (hereinafter Parent/Guardian) being 18 years of age or older, do hereby forever release, waive, discharge, and covenant not to sue TAG and its past, current, and future officers, directors, employees, members, volunteers, contractors, representatives, parents, owners, affiliates, agents, successors, and assigns (collectively TAG) for any and all damages, injuries, losses, liability, claims, causes of action, litigation, or demands, including but not limited to those for personal injury, sickness, or death, as well as property damages and expenses, of any nature whatsoever which may be incurred, directly or indirectly, now or in the future, in any way related to COVID-19 and in connection with my child attending 2020 Youth Fall Retreat. I agree not to sue Youth Retreat or TAG for any of the foregoing.

ASSUMPTION OF RISKS. I understand that while TAG and Youth Retreat Leaders have undertaken reasonable steps to lessen the risk of transmission of COVID-19 in connection with the TAG facilities, TAG is not responsible in any manner for any risks related to COVID-19 in connection with the TAG facilities. I understand that the World Health Organization has classified the COVID-19 outbreak as a pandemic. I further understand that COVID-19 is a highly contagious and dangerous disease, and that contact with the virus that causes COVID-19 may result in significant personal injury or death. I am fully aware that use of the TAG facilities carries with it certain inherent risks related to COVID-19 transmission ("Inherent Risks") that cannot be eliminated regardless of the care taken to avoid such risks. Inherent Risks may include, but are not limited to, (1) the risk of coming into close contact with individuals or objects that may be carrying COVID-19; (2) the risk of transmitting or contracting COVID-19, directly or indirectly, to or from other individuals; and (3) injuries and complications ranging in severity from minor to catastrophic, including death, resulting directly or indirectly from COVID-19 or the treatment thereof. Further, I understand that the risks of COVID-19 are not fully understood, and that contact with, or transmission of, COVID-19 may result in risks including but not limited to loss, personal injury, sickness, death, damage, and expense, the exact nature of which are not currently ascertainable, and all of which are to be considered Inherent Risks.

I hereby voluntarily accept and assume all risk of loss, personal injury, sickness, death, damage, and expense arising from such Inherent Risks. Furthermore, I represent and warrant that my child does not suffer from any medical condition or disease that might in any way hinder or prevent me from attending the TAG facilities, including, to my knowledge, COVID-19. Parent/Guardian agrees to hold harmless, indemnify and defend TAG and Youth Retreat Leaders from any and all liability for injury or damage including, but not limited to,

bodily injury, illness, personal injury, death, emotional injury, or property damage which may result from any person using the TAG facilities for Member-Sponsor/User's purposes, regardless of whether such injury, death or damage results from the negligence of TAG. This COVID-19 Assumption of Risk, Release, and Waiver of Liability Agreement ("Agreement") shall be binding on my heirs, executors, administrators, successors, and assigns. I expressly agree that this Agreement is intended to be as broad and inclusive as is permitted by applicable laws, and that if any portion of this Agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my particular exposure.
